"SUBSTANTIALLY" CHARGED Documents must "substantially" charge the fugitive with having committed a crime under the Demanding State's laws. • You cannot extradite on Capias alone • Habeas law says "substantially" charged with a crime • "Substantially charged" means there must be a showing of probable cause. • See Michigan v. Doran, 439 U.S. at 285 (1978)










































- COMMUNICATION Have solid contacts at your State's Prosecutors and Sheriff's Offices
